2015 set a record year for new Subscriber companies joining Sask  $1^{\rm st}$  Call, with 12 new companies joining. There are now 70 companies with underground facilities active with Sask  $1^{\rm st}$  Call. However, there are still many, many companies that are not part of the provincial One Call. SCGA is working on introducing Mandatory One Call Legislation in Saskatchewan which would see this number grow exponentially.

### **Canadian Senate Moves Forward with Legislation**

The Senate of Canada continues to move forward with the introduction of legislation (Bill S-233) that would require federally regulated facilities to be part of the regional One Call system. Also any facility that is buried on federal lands would be also be required to be part of the One Call System.

The first reading took place last fall and the Bill S-233 Team have reviewed industry comments and provided feedback for a second draft that is expected shortly. The <a href="CCGA WEBSITE">CCGA WEBSITE</a> (Bill S-233) provides the forum for review of this initiative and a means to provide further feedback.

### **CCGA Best Practices**

The Regional Best Practice Committees have reviewed Version 1.0 of the Best Practices for Underground Infrastructure Damage Preventions and recommended that 13 changes/revisions be made. The CCGA Board has approved this recommendation and the electronic version will be updated and be available on the SCGA website shortly.
